



IMPORTANT NOTICE

2026 RENEWAL: Retail Consumption on the Premises License – LTD

Your 2026 Alcoholic Beverage License renewal is due by Friday, October 31, 2025. Any renewal application not filed by November 15, 2025 will be assessed a late filing fee of **\$250.00 per month**.

Your 2025 Alcoholic Beverage License expires at midnight on December 31, 2025. Failure to renew your license by December 31, 2025 will require you to re-apply for a new license and appear before the Alcohol Beverage Licensing Board before you can serve or sell alcohol in your establishment. The earliest available meeting will be held on Thursday, January 8, 2026.

IF YOU DO NOT RENEW BY DECEMBER 31, 2025, YOU WILL NOT BE ABLE TO SELL ALCOHOL AT ALL UNTIL THE NEW LICENSE IS ISSUED (January 8, 2026 at the earliest.)

Payment in full is required with the submission of the renewal application. In addition, any monies due the City of Roswell must be paid as applicable – occupation tax, excise tax, property tax, utility and sanitation fees.

No exceptions.

- All liquor, wine and malt beverage license holders are notified that requests for license renewals must be made during the month of October to ensure renewal requests are in proper form to be presented to the Alcohol Beverage License Board on **Thursday, December 4, 2025**
 - If the ownership or licensee for the premises changes, you must apply for a new alcohol license.
 - Any outstanding excise tax or other delinquent charges owed to the city, or noncompliance with the TIPS training requirement may delay the renewal of your license.
 - IF YOU ARE NOT RENEWING YOUR LICENSE, RETURN ONLY THE "NON RENEWAL AFFIDAVIT" INCLUDED IN THIS PACKET.

Alcohol **Consumption on the Premises** License

City of Roswell Ordinance Requirements

All holders of licenses to sell liquor, beer or wine by the drink in the City of Roswell are notified that your license will not be renewed unless you have complied with Section 3-7-3 of the *City of Roswell Alcoholic Beverages Ordinance*. This provision requires that the serving of meals shall be the principal business conducted, with the serving of alcohol consumed on the premises as only incidental thereto. More than 50% of the outlet's income must be derived from sale of food on the premises. All requests for renewal must show that the business has complied with this provision.

Each applicant for renewal of a Consumption on the Premises license will show the amount of income derived from the sale of food and the amount of income derived from the sale of alcoholic beverages and the gross amount of income received for the twelve (12) months indicated, or for the months that the license was granted. These figures are subject to audit by the City of Roswell.

**NOTICE & AFFIDAVIT
TIPS (Training Intervention Procedures)**

Chapter 3, Article 3.2, Section 3.2.10 of the Alcoholic Beverage Ordinance of the City of Roswell requires certification of the licensee of a restaurant, convenience store, grocery store and package store by attendance at TIPS (Training Intervention Procedures Program) or approved alternative program that shall be verified and signed off by the Chief of Police.

The applicant shall have 6 months from the date of the granting of the license to complete such training and submit certification to the Alcohol Beverage Licensing Board.
