
City of Roswell 2045 Comprehensive Growth Plan Update

What is the Comprehensive Growth Plan?

The 2045 Comprehensive Growth Plan is a blueprint for the future and economic growth of our city. It will outline the community's vision, goals, and strategies for land use, housing, transportation, public facilities, and infrastructure. This plan is designed to guide decision-making and help ensure balanced growth.

Why are we updating it?

All Cities and Counties in Georgia are required by the Georgia Department of Community Affairs (DCA) to update their comprehensive plan every five years. The 2045 Comprehensive Growth Plan will serve as Roswell's comprehensive plan update. Beyond state requirements, updating the plan also provides an opportunity to address current challenges and plan for future economic growth and investment.

How is the 2045 Comprehensive Growth Plan different?

The 2045 Comprehensive Growth Plan update is different because it will use market and economic analysis to develop a vision that is focused on growing jobs and economic opportunities while protecting existing residential neighborhoods. Additionally, this plan update will focus strategies for key corridors and centers that promote future development. These corridors and centers represent critical areas where we need to stimulate economic activity, attract new businesses, and enhance the community's vitality.
